5. Job Descriptions for Caney Market: Council was presented with job descriptions for Caney Market. Motion made by Patterson; seconded by Butts to approve. 7-0 Motion Carried


Council returned from Executive Session at 8:30 pm with motion made by Patterson; seconded by Ellison to regular meeting with no action taken. 8-0 Motion Carried
