

ORDINANCE NO.

AN ORDINANCE AMENDING THE PROVISIONS OF CHAPTER 15 (UTILITIES), ARTICLE 1 (WATER), SECTION 15-116 (RATES), OF THE CODE OF THE CITY OF CANEY, KANSAS, AND ORDINANCE NO. 2151 PROVIDING FOR RATES FOR WATER SERVICE IN THE CITY OF CANEY, KANSAS.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF CANEY, KANSAS, AS FOLLOWS:

Section One. That Chapter 15 (Utilities), Article 1 (Water), Section 15-116, Subsection

(b) (Regular Rates – known as Tier #1) of the Code of the City of Caney, Kansas, be and is hereby amended as follows: 15-116(b) RATES

Rate 1- \$36.00 per month, commencing as of the billing cycle ending December 10, 2016

Rate 2- \$46.25 per month, commencing as of the billing cycle ending December 10, 2016

Usage Rate- usage rate shall apply at the rate of \$2.85 per 100 cubic feet of water usage per month for customers within the City of Caney (748 gallons; \$3.31 per 1000 gallons) and \$3.10 per 100 cubic feet of water usage per month for customers outside of the City of Caney limits (748 gallons; \$4.14 per 1000 gallons).

(c) (Tier Rates) of the Code of the City of Caney, Kansas, established for water rates when the City purchases and distributes wholesale water and for high usage during emergency water conservation status set by the City.

Tier #2: Usage rate shall apply to water supplied by the City of Caney to its customers from a wholesale water source or by usage of water to exceed 20% of normal monthly customer average without the proof of a water leak repair. The rated for Tier #2 shall be: \$6.20 per 1000 gallons for customers within the City limits and \$7.24 per 1000 gallons for customers outside the City limits.

Tier #3: Usage of water that exceed 40% of normal monthly customer average without the proof of a water leak repair. The rated for Tier #3 shall be: \$9.60 per 1000 gallons for customers within the City limits and \$10.34 per 1000 gallons for customers outside the City limits.


Section Two. Due to the cost operation and maintenance of the water system increasing every year, The City of Caney, Kansas will increase the water rates by 5% beginning with the January billing 2023. The City will continue to do this every year as it deems necessary to produce quality water for the customers of the City of Caney Kansas.

Section Three. Except as amended hereby, all remaining provisions of Chapter 15 (Utilities), Article 1 (Water), including all other subsections of Section 15-116, shall remain in force and effect.

Section Four. Nothing in this Ordinance shall be construed to require the City to provide water outside of the corporate limits of the City of Caney.

Section Five. This Ordinance shall take effect upon this publication in the official City Newspaper.
